There are many ways to vote. You may vote in person at the Annual Meeting/BBQ at 6:30 PM on Thursday, June 25th, 2009. You may send in this ballot by US mail (address below), or email to contactus@englewoodunleashed.org. All members who have paid their dues can vote. Any new member can vote if they join before the Annual Meeting at 6:30 PM on Thursday, June 25th.

You may vote for qualified write-ins. These are the qualifications for candidates as stated in our bylaws:

Article V,

Section B. QUALIFICATIONS

1. Members of the Board of Directors shall be voting members of the organization in good standing.
2. Members of the Board of Directors shall be subject to the financial self-interest/conflict of interest exclusions described below.

Section C. FINANCIAL SELF-INTEREST / CONFLICT OF INTEREST EXCLUSION:

1. No member of the Board of Directors shall have a financial self-interest in the investments, fundraising efforts of the organization, projects funded by the organization, or on-going maintenance efforts paid for by the organization.
2. No member of the Board of Directors shall have a financial self-interest in any Englewood off-leash parks themselves.
3. Any member of the Board of Directors shall automatically resign if a financial self-interest or other conflict of interest arises, or if the Board member is or has been convicted of a fiduciary crime or fraud.
4. Each member of the Board of Directors shall sign an ethical statement stating that they do not have financial self-interest or other conflict of interest with the organization, and that they have not been convicted of a fiduciary crime or fraud. Furthermore, each member of the Board of Directors shall disclose on this ethical statement if they have ever been convicted of a Class II felony or above.

3	Change to <i>Article V, Sect. D (2) first sentence</i> , to now read as, "...if necessary, at least two (2) weeks in advance of Board of Directors elections..."		
4	Change to <i>Article V, Sect. D (3) (d)</i> , to add text "or email to organizations current email address."		
5	Change to <i>Article V, Sect. F (2)</i> , to now read as, "Following each annual election, the elected Board of Directors shall appoint/assign new officers for a term of...."		
6	Change to <i>Article V, Sect. J (5), first sentence</i> , to add text, "...Board meetings or via email and/or phone and require a quorum of a minimum of four (4) Directors."		
7	Change to <i>Article VI, Sect. A (4)</i> , to add text, "...treasurer, all checks over \$100."		
8	Change to <i>Article VI, Sect. C (1)</i> , to add text, "...as required or will be assigned to another Director."		
9	Change to <i>Article VIII, Sect. C, second sentence</i> , to now read as, "General information, including the Corporation's Articles of Incorporation and Bylaws may be accessed and downloaded at no charge."
